It is noted that the above contract price is exclusive of local indirect taxes but inclusive of a balance of **Four Million Seven Hundred and Sixty-Seven Thousand One Hundred and Ten Ghana Cedis Fifty-Three Pesewas (GH¢4,767,110.53)** from the Ghana Productive Safety Net Project.

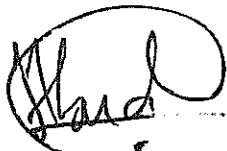
The total estimated indirect local taxes amounted to **Four Million, One Hundred and Five Thousand, Eight Hundred and Ninety-Four Ghana Cedis Eighty-Seven Pesewas (GH¢4,105,894.87)** only as finalized at the Contract negotiations based on the estimates provided by the Consultant in Form FIN-2 of the Consultant's Financial Proposal.

The duration of the assignment shall be three (3) months while the contract duration shall also be One Hundred and Eighty (180) days commencing from the effectiveness date of the contract.
